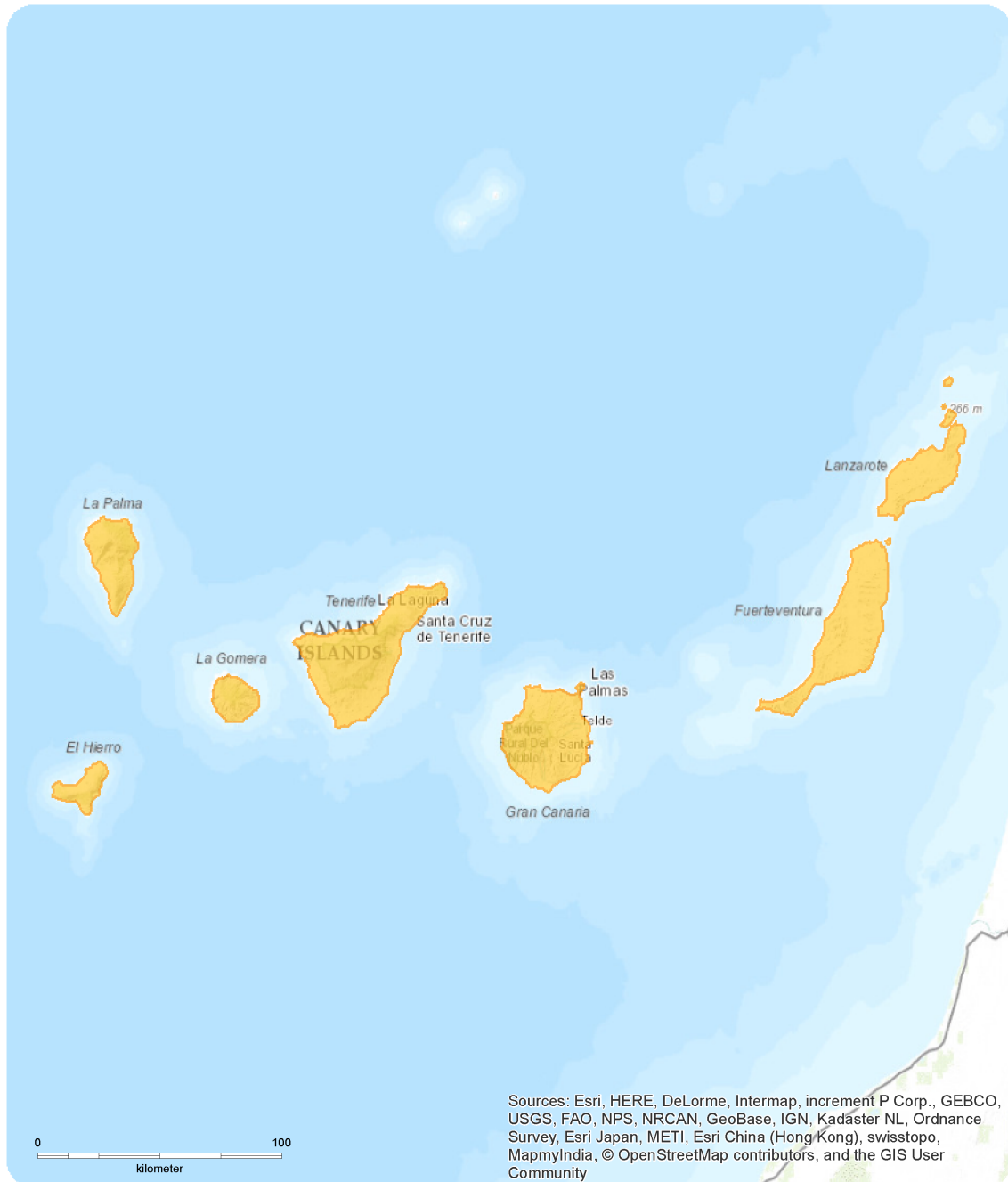

Distribution Map

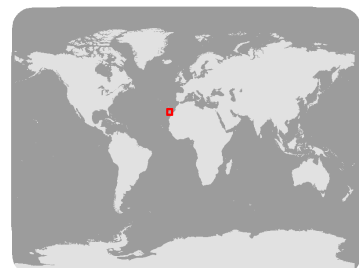
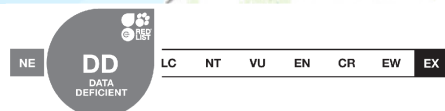
